From Kingsport, TN: Take U.S. 23N to Gate City. Bear right onto BUS U.S. 23 at traffic light. Turn right at traffic light at GateCity High School. At stop sign, turn right onto Rt. 71(Jackson St.). Go about 1 mile and turn left onto Rt. 72 toward Ft. Blackmore. Stay on Rt. 72 for approximately 16 miles. Park will be on left.

From Abingdon, VA: Take U.S. 19/58A to Castlewood Turn left at first traffic light onto Rt. 65 towards Dungannon, Va. Continue about 10 miles to Dungannon. At stop sign, turn left. Park will be about 1.5 miles on the right.

From Wise, VA: Follow 58A to Coeburn. Turn right onto Rt. 72 and continue about 11 miles to Dungannon, Va. Follow Rt. 72 through Dungannon. Park is about 1.5 miles on right.
