

## 2011 Trail Riding Hours Log Form

\*Must be a 2011 SCRHA Member to participate.

\*Horse and rider must be nominated and all fees paid before trail hours can start accumulating.

\*Trail hours are forward moving hours and DO NOT include any rest, visiting, or eating breaks

\*Participant is responsible for keeping up with their own trail hours. Hours should be rounded to the nearest full hour. DO NOT count minutes or half hours.

\*Trail riding at any location, state, etc. on trails or roads count toward trail hours.

\*Riding in riding rings, barn aisle ways, and horse shows DO NOT count towards trail hours.

\*Date, location, and hours ridden must be logged on form for each ride.

\*Deadline for turning in trail hours accumulated is November 15, 2011.
